Many of our children have feeding issues and need the professional assistance that our therapists provide. For this reason, The Arc Kohler School would like to continue to provide breakfast and lunch free of charge for all of our students.

As of July 1, 2007, the State Board of Education amended N.J.A.C.6A:23-4.5(a)20 which will require Board of Education action on your part for us to continue this practice. As per NJDOE regulations, we are requesting a resolution from the Board of Education, on letterhead, stating that The Arc Kohler School can provide breakfast and lunch free of charge to all students. The sample resolution attached contains the actions requiring Board of Education authorization.

The NJ Department of Education requires that the resolutions be received by August 31, 2014. With the upcoming summer recess, we ask that you provide this resolution by June 30, 2014.

NOW, THEREFORE, it is hereby resolved that the <u>Union</u> Board of Education acknowledges the foregoing actions and in accordance with N.J.A.C..6A:23-4.5(a)20 authorizes The Arc Kohler School to include the costs of meals provided within the annual tuition rate charged to students.
