This Agreement entered into the first day of July 2012, between the Union County Educational Services Commission, having its principal office at 45 Cardinal Drive, in the Town of Westfield, County of Union, State of New Jersey, hereinafter referred to as U.C.E.S.C., and the Union Board of Education, having its principal office at 2369 Morris Avenue, in the City of Union, County of Union, State of New Jersey, hereinafter referred to as the Public School District.

Whereas, the Public School District lacks necessary facilities for the provision of a suitable Summer Educational Program for certain students classified as Preschool and Elementary Autistic and students classified with Multiple Disabilities, and Behaviorally Disabled that require a therapeutic environment for the Summer of 2012; and,

Whereas, the U.C.E.S.C. has established suitable classes which provide a summer educational program for students classified as such, and has maintained the necessary facility to engage in such an educational program;

Now, therefore, in consideration of the promises and mutual promises and covenants herein contained, it is agreed by the parties hereto that:

- 1. U.C.E.S.C. shall provide a suitable educational program in accordance with procedures and regulations established by the New Jersey Commissioner of Education and the New Jersey State Board of Education, for those students classified as Preschool and Elementary Autistic and students classified with Multiple Disabilities, and Behaviorally Disabled that require a therapeutic environment for the Summer of 2012; and,
- 2. The Public School District, as a consideration for such educational programs shall pay tuition as follows:
  - a. Extended School Year Program for Multiple Disabilities and Autistic: Four thousand one hundred sixty-two dollars (\$4,162.) per pupil, for the period of July 2 through August 3, 2012 (24 days) Westlake School, 1571 Lamberts Mill Rd, Westfield, NJ 07090.
  - b. Extended School Year Program for Behaviorally Disabled Students that Require a Therapeutic Environment: Six thousand nine hundred fifty-five dollars (\$6,955.) per pupil, for the period July 2 through August 3, 2012 (24 days) Lamberts Mill Academy, 1571 Lamberts Mill Road, Westfield, NJ 07090.
  - c. <u>Summer School Program for Preschool and Elementary Autistic and Multiply Disabled</u>: Four thousand nine hundred seventy-eight dollars (\$4,978.) per pupil, for the period July 2 through July 31, 2012 (21 days) Crossroads School, 45 Cardinal Drive, Westfield, NJ 07090.
