As we discussed, here are some points for your clarification:

- 1. Springfield had a long-standing agreement with the county for the use of Meisel field as a home field. Springfield would maintain the facility for almost exclusive use.
- 2. Around 1999, there was an environmental determination that closed the field for about 6 years. Subsequent renovations resulted in our use for one season and the field was condemned once again. We have not used it since and the county never renewed the agreement.
- 3. We then looked for help from surrounding districts. Several years ago, Ted Jakubowski and I reached agreement after our athletic directors worked on operational procedures.
- 4. As it stands, we retain all the gate receipts; Union retains all concession receipts.
- 5. We would appreciate continuation of our arrangement for the next school year.
