The Township of Union Public Schools will ensure continuity of services in several ways each school year. The school district will leverage federal funding made available to expand academic and enrichment opportunities throughout the school year. Teachers will differentiate instruction to address student's specific learning gaps. Faculty will be responsible for integrating activities that emphasize social and emotional well-being. Academic needs of students will continue to be assessed using diagnostic and formative assessments and supportive programs and resources such as but not limited to after school programs, summer programs, enrichment classes, credit recovery programs and transition programs. Social emotional learning will be demonstrated through lessons, wellness teams, SEL labs, mentoring programs and counseling focused on enhancing relationships and connections between all stakeholders.

The Township of Union Public Schools requested public comment prior to the development of the Safe Return Plan.
