1. The establishment of a Self-Contained Behavioral Disabilities Program in Battle Hill Elementary School. The unmet student needs that will be addressed are the provision of behavioral supports and interventions.

2.

- a. The age range in the Battle Hill Elementary School program is as follows: students aged 6.5-10.5 years of age. The class will have a maximum of 9 classified students. Class size may be increased beyond 9 students to a maximum of 12 classified students with the addition of a classroom aide.
- b. The Common Corte State Standards, Next Generation Science Standards and the Core Curriculum Content Standards are addressed through instruction with the district adopted curriculum.
- c. Establishment of this program allows student to remain in the least restrictive environment.
- d. This class, per students' IEPs, will provide the opportunity for students to interact with nondisabled peers because there are general education students in the school.
- e. One certified special education teacher is needed per class. An aide will be required if class size exceeds 9 students.
