## **Proposal:**

In response to your request to provide a Professional Development Day for your ESL team, we are submitting this proposal on behalf of Language & Literacy Associates for Multilingual and Multicultural Education (LLAMAME, LLC).

The purpose of LLAMAME, LLC is to help educators throughout New Jersey develop effective learning environments for culturally and linguistically diverse students. LLAMAME, LLC provides assistance to teachers, instructional assistants and administrators serving Multilingual Learners (MLs).

This proposal includes one full day of training (2 hours, based on the schedule and discussion shared with us). This interactive training will cover:

• Introduction to the 2020 WIDA Framework: Big Ideas, Guiding Principles, Structure of the Framework and resources for grade level bands.

This quote includes ½ of a Professional Development Day on September 4, 2024 for the ESL team. Our associates, **Julie Ochoa and/or Dr. JoAnne Negrin** will present the sessions. In the event either presenter is unavailable, another associate will substitute.

Rate for ½ day: \$ 2,000.00 inclusive of mileage

The daily start and end times will be based on your district's contractual agreement with teachers. The number of participants is not to exceed 40.

#### **Additional Information:**

Sheltered Instruction Training is usually delivered as a three training and is meant for teachers in all grade levels and content areas.

SEI strategies have proven to be effective techniques which provide access to the content standards for current and former MLs as well as general education students (Short, Echevarria & Vogt, 2012). The training sessions will consist of demonstrations, simulations, examples and hands-on activities that will allow teachers to go back to their classrooms to implement the strategies and to refine lessons that impact student achievement.

## SEI training covers:

**Day 1:** A common framework of second language acquisition; the WIDA standards, ACCESS for ELLs® assessment, interpretation of the data; a crosswalk to the district's Teacher Evaluation Model; and, an explanation of the ELL Scaffolding Initiative -NJ Model Curriculum

**Day 2:** Overview of the Sheltered English Instruction Model, and in depth study of the first two components, Lesson Preparation and Building Background.

**Day 3**: In depth study and application of the components of Comprehensible Input, Interaction, Lesson Delivery, Practice and Application and Review and Assessment. In addition, two features of Strategies will be highlighted: vocabulary and high order thinking skills.

These intensive training sessions include research-based methodologies as well as opportunities to model and practice all of the suggested components and features. The goal is for participants to reflect on the eight components which contain thirty features as well as their own current practices in order to see how the information can guide them to differentiate instruction for the various proficiency levels; engage the students in deliberate listening, speaking, reading and writing activities; and, conduct formative assessments to modify instruction. An online networking system will be developed for support, questions and answers, sharing of resources, etc. during as well as after the training.
