

My name is Austin Lopes and I am the alumni who approached the board last night about the request of using the Union High School's athletic facilities in order to hold an alumni game fundraiser for Jason Lopes' scholarship. I would like to hold this event on May 3rd at the high school's athletic facilities in order to continue the scholarship I was very fortunate to be awarded. Also, I want to continue his legacy onto his actual graduation year of 2016 in order for his past colleagues and friends to have a sense of remembrance of him still. On this day I would like to have spectators watching multiple alumni games going on in order to make it a community event. While, non-registered players are spectating they will be able to make a donation towards the cause. On the other hand, those participating will pay a relatively small fee of \$20-\$30 in order to play and get a t-shirt of a specific color to divide up the teams of odd and even graduation years, there will also be shirts advertising the event on sale for spectators.
