AMENDMENT

SCHOOL RESOURCE OFFICER SERVICE AGREEMENT

THIS AMENDMENT, made on this 7th day of December, 2021 Between:

TOWNSHIP OF UNION, a Municipal Corporation of the State of New Jersey, hereinafter referred to as the "Township", and

UNION TOWNSHIP BOARD OF EDUCATION, whose address is 2369 Morris Avenue, Union, New Jersey 07083, hereinafter referred to as the "Board".

WHEREAS, the Township and the Board entered into a School Resource Officer Agreement in 2016 for the Township to provide a Board with a School Resource Officer ("SRO"); and

WHEREAS, the Township and the Board wish to amend the 2016 School Resource Officer Agreement to continue the terms for the 2021-2022 school year.

NOW THEREFORE, for good and other valuable consideration set forth herein, it is agreed that:

- 1. The Township shall provide to the Board a SRO for the 2021-2022 school year.
- 2. The Board agrees to pay the Township for the SRO's services, \$63,000.00 with payment to be made no later than December 31, 2021 upon submission by the Township to the Board of a fully executed Board voucher.
- 3. The Township further agrees to provide the Board with an insurance certificate naming the Board as an additional insured under the Township's Casualty and Liability insurance policy.
- 4. All other terms set forth in the 2016 School Resource Officer Agreement shall remain in full force and effect.
