



Chapter 415. Recreational Facilities

§ 415-1. Use restricted to residents and guests.

The use of all recreational facilities under the control of the Township of Union in the County of Union shall be restricted to residents of the Township of Union and guests of said residents as hereinafter provided.

§ 415-2. Guest to be accompanied by resident.

No guest shall use any of said facilities, unless he shall be accompanied by a resident of said Township of Union.

§ 415-3. Proof of residency.

All residents using any of the recreational facilities of said Township shall be required, on demand of the Recreation Superintendent or the person then in charge of said facility, to furnish proof of residency.
