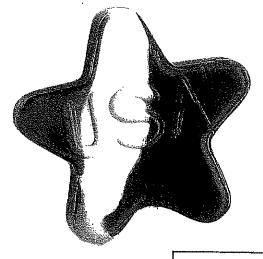

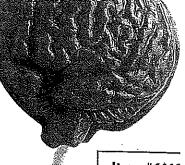

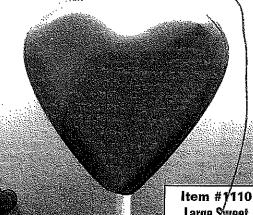

Third-Party Product Sales Fundraising Agreement

The required procedures and policies set forth below are critical to the handling and resale of Chick-fil-A® brand products for fundraising purposes.  Approved Chick-fil-A[®] coolers with lava packs will be provided. During hot product holding, the cooler lids must stay closed.
- All cold products must be held and served at 40°F or lower. This procedure is critical in order to keep cold food products safe for your customers during holding.
 - All cold products must be held in an approved Chick-fil-A TMS with micro-ice. Approved Chick-fil-A[®] coolers with
 micro-ice will be provided. During cold product holding, the lids must stay closed on the micro-iced coolers,
- 3. NO product may be served past its assigned holding time. Please check the Quality Tracking Card in each TMS to comply with assigned holding times for Chick-fil-A® products. 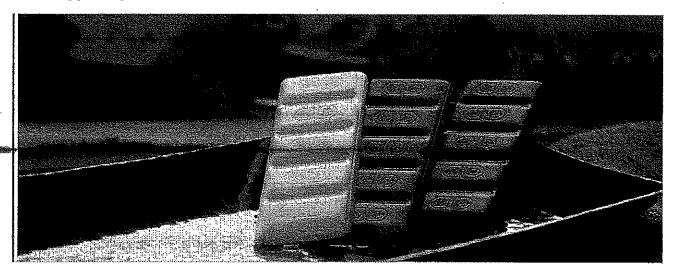
