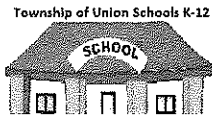

Why we need a Mrs. UHS ?

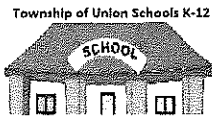
- For years Mr. UHS has been a main attraction for students.
