## **Affiliation Agreement**

This constitutes an Affiliation Agreement between The Union Board of Education and The Family Center At Montclair.

#### INTRODUCTION

The purpose of the Affiliation Agreement is to maintain a formal cooperative working relationship between the Union NJ Board of Education and The Family Center At Montclair. It is hereby understood that a mutual referral agreement exists between the above agencies.

#### **RESPONSIBILITIES OF BOTH PARTIES**

The Union NJ Board of Education:

The Union NJ Board of Education personnel agree to refer students in need of a Mental Health Screening or Psychiatric Evaluation to The Family Center At Montclair.

They will do so by calling the Family Center At Montclair. The Union NJ Board of Education Personnel will be responsible for:

- a. The identification and referral of students in need of services at the cost of \$100 for a screening and \$450 for a full psychiatric evaluation to be paid to the Family Center at Montclair by the Union NJ Board of Education.
- b. Notify the student's parents of their recommendation for mental health services.
- c. Provide by secure fax to the Family Center at Montclair the reasons for the referral and contact information as outlined on the referral form provided by the Family Center.
- d. Solicit from and provide to The Family Center At Montclair follow up information on the student referred.

The Family Center At Montclair shall provide mental health services to the students of the Union NJ Board of Education.

The Family Center At Montclair will be responsible for:

- a. Providing mental health screenings to referred students from the Union NJ Board of Education as soon as possible after the referral is made but within 24 hours.
- b. Provide full psychiatric evaluations to referred students from the Union NJ Board of Education as soon as possible after the referral is made.
- c. Provide to the referring personnel of the Union NJ Board of Education documentation of the mental health screening or psychiatric evaluation and recommendations in a timely manner.
- Assist referred students from the Union NJ Board of Education with follow up treatment if necessary.
- e. Bill the Union NJ Board of Education only for services contracted for under this agreement.



#### Additional Responsibilities:

>>

- 1. Both parties to this agreement will abide by all Federal and State laws dealing with the confidentiality of information,
- 2. Both parties shall provide for an exchange of pertinent information about the referred student during the period when services are provided. The referred student's guardian will be asked to sign a release of information agreement during the intake process for this purpose.
- 3. It is understood that students referred by the staff shall not be denied treatment or be discriminated against on the basis of sex, race, creed, national origin or sexual orientation.
- 4. The Family Center At Montclair agrees to indemnify and hold harmless the Union NJ Board of Education from any and all liability arising out of any negligent act of omission or commission by any of the Family Center At Montclair agents, servants and representatives.
- 5. The Union NJ Board of Education agrees to indemnify and hold harmless The Family Center At Montclair from and any and all liability arising out of any negligent act or omission or commission by any of the Union NJ Board of Education's agents, servants, and representatives.
