SUPERINTENDENT'S REPORT:

Good evening. To begin I like to take this opportunity to welcome the Union High Jazz Ensemble under the direction of Ms. Laura Muller. We would like to highlight and present them to you.

Ms. Miller presented the Jazz Ensemble. After their performance Ms. Miller introduced all students in the Jazz Ensemble.

Mr. Tatum continued with his Superintendent Report:

Student/Staff Attendance for the month of April - Students 94.8%; Staff 95.0%.

Monthly Highlights:

- KMS held a fundraising event called "Dancing with the Staff' on Friday, May 1, 2015. Over \$2,000 was raised at this event.
- Livingston School has raised over \$3,000 for the American Heart Association through Jump Rope for Heart.
- Union High School's ROTC won the Northeast United State Raider Meet
- UHSPAC Production of Duke Ellington's Sophisticated Ladies is the most nominated musical in the Paper Mill Playhouse Rising Star Awards with 16 nominations and 1 honorable mention.

- Union High School Symphonic Band, under the direction of Laura Muller, received a good rating
- o Union High School Indoor Color Guard, under the direction of PJ Tankard, received superior rating and first place
- Union High School Jazz Ensemble, under the direction of Laura Muller, received superior rating, silver award and second place for the Outstanding Overall Jazz Ensemble
- Union High School Swing Choir, under the direction of Melissa Abate and James Mosser, with choreography and staging by Jennifer Williams, received superior rating, gold award and first place for Outstanding Overall Specialty Choir.

Districtwide Planning Committee Update:

The districtwide planning committee met on Tuesday, April 28, 2015. At this time, members of the communication's sub-committee presented a new district mission statement. This new statement will be presented to the board for final review and approval. Upon completion of this process, the mission statement will be posted on our district website. Also, a parent subcommittee presented a PowerPoint presentation on the perceptions of parents that currently exist between our district and this faction of the community. This feedback will be used to improve communication in this area. I would like to commend this sub-committee for their hard work and efforts. The main topic of discussion was centered upon school climate and culture with the assignment for all members to research school climate surveys as a means to adopt one for administration in the district. Our next meeting will be held on Tuesday, May 26, 2015, at 6:30 PM in the administration building.

Student Recognition:

- 1. Shannyn Belser, 7th grader at Burnet, was the winner of the 2014 T-Shirt Contest at the Adopt-A-Park event.
- 2. Shenelle De Coteau, 8th grader at Burnet, was the 1st place winner of the Law Day Poster Contest. This is the 3rd year a Burnet student has won 1st place.
- 3. Outstanding Jazz Solo Award was given to Terence (TJ) Fuller, 10th grader at UHS, at Festival Disney.
- 4. Senior Awards: Dr. Lishak will now share the award recognition recipients from last night's senior award ceremony.

Dr. Lishak stated that she had the opportunity to attend the award ceremony last night and it was beautiful—it was wonderful, well attended by parents and family members. It was fantastic. The Union High School awards were held last night and over 200 monetary scholarships were handed out. Our 12th grade students were recognized for outstanding achievement for academics, athletics, music, art and various career paths. Additionally, Union High School named Valedictorian and Salutatorian for the graduation year. I just want to give a little bit of information on these two wonderful students.

The Salutatorian this year is Brianna Haggens Johnson – she has a weighted GPA of 4.8 and unweighted of 3.97. She will be attending Notre Dame in the fall to study account and finance with a minor in Spanish. She received \$62,040 per year in scholarship money to attend. She will only have to put a little out-of-pocket. Her activities included ski and snowboard club, Vice President of the Spanish Honor Society, Model UN, National Society of High School Scholars and she edited the 2015 year book.

This year's Valedictorian is Andrea Gomez – she was one out of 1,000 students in the United States to receive the Bill Gates' Millennium Scholarship. Andrea will be attending the University of Pennsylvania in the fall – College of Arts and Science – where she will be studying neuroscience. Her weighted GPA is 5.22, with an unweighted GPA of 4.1. Her activities include Student Vice President, Senior Class President, President of the National Honor Society, Corresponding Secretary of the French National Honor Society. She is a member of the Character Education, Peer Ambassador, Varsity Tennis player and a member of the French Club and if that was enough, she also has a black belt in ti-kwan do.

Mr. Tatum continued with his Superintendent's report:

Upcoming Events:

Mr. Arminio stated as part of the Superintendent Report – Dr. Lishak has an update on the PARCC test. Also, I was at the award ceremony last night and I was thoroughly impressed, not only with those two, but all the other honorees and what they have accomplished.

Dr. Lishak stated: The District has completed both sections of the PARCC testing grades 3 to 11. Based on the numbers collected, our District will fall into the 79% participation rate which is far below the required 95% the New Jersey Department of Education is looking for (NJDOE). This does not include any absent or non-documented refusal students. At this point, we have not been provided any official information on what the repercussions from the NJDOE will be as a result of not meeting the goal rate; however, we have been told the NJDOE is discussing the possibility of withholding State funding or corrective actions plans for Districts who did not meet the goal.

I wanted to take the time to address a few issues that came up at our last Board meeting regarding the PARCC assessment. The Board, the Administration along with the student, parents and teachers are frustrated with the amount of time the testing has taken during this school year. The teachers who came to speak at last month meeting were justified in saying they have lost valuable instruction time based on the requirements placed on the District as far as allotted time for testing and for the use of certified test administrators – meaning we had to use

certified teachers to administer the tests. According to the NJDOE, the amount of time allotted for each test will be examined and possible changes could be made prior to the next PARCC administration. However, at that same meeting, an impression was given that the District had the opportunity to request the use of paper test materials. This is not the case. The NJDOE will not allow for paper material to be used unless the circumstances warranted. Unfortunately, our District does not fall into that category.

Additionally, we held this school year, and to continue to plan for next school year, PARCC workshops so that parents can find out more information about the PARCC test itself and we plan to do that during the 15-16 school year. But as I was researching this information, I came across a website that allowed for PARCC questions and answers and I thought some of them you might find interesting and I'm sure you may be giving a few comments. Under the NJDOE's website it says:

How will PARCC affect our students' teachers? This is a question that I have been asked – this is right off the website: For teachers, State law requires a portion of annual evaluations for only teachers of mathematics and English language arts in the tested grades to be based on growth on student assessments. This affects less than 20 % of teachers. The portion of a teacher's evaluation based on growth on student assessments is being reduced to 10% in 2014-15 – down from 30% the previous years. Dr. Lishak stated I wanted to make sure people understood that – when someone would send in a letter, that question was on there.

Second question - Will PARCC sell personal information about students? The answer to this according to the website is No. The website states: Protections are in place at both the State and federal levels, and through all contracts and agreements. Dr. Lishak stated again they are saying this also will not be sold and again it is a question that has come up.

Dr. Lishak stated that the last one that I thought you might find interesting as the Board and the public is how much is this new test costing our town? Dr. Lishak stated that the answer from the NJDOE is there is no local cost involved in developing or scoring the PARCC exam. The State pays for all PARCC exams. None of the costs for PARCC comes directly from the local school budget. Dr. Lishak stated that is correct. Developing and scoring the test there is no cost. But there was a cost in putting in all the infrastructure and the technology that we needed in addition to substitutes brought into the building and coverage for testing. Although these are the answers that are up on the website, I believe you needed a little more information on that.

Mr. Arminio asked if anyone on the Board had any questions or comments for Dr. Lishak. Dr. Francis stated that the biggest cost is the cost of instruction time to our students.

Mr. Tatum stated just a point, I think we analyzed the cost early for the PARCC for classroom and infrastructure needs and so forth.

Dr. Lishak stated that in putting in all of the technology that we needed and we went over it – it took us a couple of years to get where we needed to go – we reached somewhere in the area of about \$350,000 but that does not count the amount of costs we incurred in just giving the test. Finding coverage, getting subs to cover this – while we had another teacher administer the

test because the regulations state that it had to be a certified teacher doing it - there is also another cost which we would have to analyze at the end of the year.

Mr. Arminio stated that as part of the Superintendent's Report there is a statement that I would like read before we go on with the rest of the agenda. As President of the Township of Union Board of Education I have prepared this statement and I would like to read it. The statement was prepared in consultation with Mr. Tatum, as Superintendent, and granted permission of Dr. Lishak, the Assistant Superintendent. This matter is a personnel matter and in regards to Dr. Lishak – the Township of Union School District tenured employee. Listed in tonight's agenda is the 2015-2016 contract for Dr. Lishak. This contract is listed as required and not as a matter for consideration for reappointment but as review and approval of the terms set within the contract itself. Last year, questions were raised regarding the resume that Dr. Lishak submitted for a position that was posted within the District in 2008 and which she was subsequently hired. At that time, the Board discussed and reviewed the issue during Executive Session. Mr. Tatum investigated the concerns that were raised and reported the findings to the Board. Mr. Tatum would you like to say a little bit to that.

Mr. Tatum stated as a result of the findings – appropriate action was taken and will not be discussed because this is a personnel matter and considered closed. Dr. Lishak, through her hard work, has a obtained a doctorate degree while working in the Township of Union's public school district.

Mr. Arminio stated that I have confirmed with Dr. Jacobowski, former Superintendent at the time of Dr. Lishak's hire. Dr. Jacobowski acknowledged to me that when he interviewed her at the time, it was a position of Director – he was aware of the brief period of time that she served as a principal, although he could not recall the exact number of days or weeks. He acknowledged and understood, it was for a very brief period of time. She was hired as the Director of Curriculum and not as a building principal. Thank you.

Mr. Arminio stated Mr. Damato I understand we have some special guests in the auditorium, if you would recognize them and may be they can stand up after introduce them. Mr. Damato stated that I believe we have some students from Mrs. O'Neill and Mr. Costello's classes here and if you would like to raise your hand – I know that some of you have a project to do and you had some choices and one of the choices was to come to a Board of Education meeting. Welcome to the Board of Education meeting. I hope that you learn something and hopefully consider public service to your community in the future and welcome to Union Board of Education.

Mr. Arminio stated if you have any questions later on, make sure you ask them.

COMMENTS FROM THE PUBLIC ON RESOLUTIONS ON THE AGENDA:

Mr. Arminio stated now we have the part of the agenda where the comments from the public on items on the agenda. Please come to the microphone.

Public No. 1: She wanted to make a general comment that she wants to ensure that the people that are hired for the School District are thoroughly vetted and are hired due to their

education and experience related to the job that they applied for and that they have valid credentials. The community needs to be able to trust that every employee that is hired in the District – that we can trust in them and of course, we need to give you that trust that you are going to ensure that the best people are hired and that they meet all the criteria for the position.

Patrick Brooks stated: I came here tonight to talk about the presentation – prioritizing my thoughts sometimes I have more suggestions. I came tonight was about air conditioning. Both my sons go to Battle Hill - my son has asthma - I came to talk about that but I came to find that I guess I can talk about PARCC and common core, I find that tonight that they blend together a little bit. I hear that a band-aid is being put for the situation and that hopefully in the coming weeks air conditioning will be up and running within the school in some fashion. It is o.k. I appreciated the expedition of the process and trying to get something. The money – my understanding of it – that was suppose to be set in place for next year – has been taken and the permanent fix has been taken and is no longer in place. All this money that has been put in the system for computers – it is almost like a double edge sword – you put all these computer in – but not realizing that we have to keep them cool and it sounds stupid but I'm talking about keeping computers cool when I should be talking about my kids school. The children in school need to pay attention - if it is 90 degrees in their classroom - they can't function. I know I can't function. I work in an environment surrounded by computers - it is 65 degrees and if it goes any higher – fans are put in to circulate the air. These kids are 6 on up and the money should be spent to keep them cool so that they can just have an education – the computers for the tests that even our Governor has said – he only took it on for the money. This isn't right. It is a double edge sword – yes, Mr. Tatum was brave enough to take on – tackle this – I don't envy you – the job you have to take on - there are so many things you can do and try to do to fix where it is lacking in the class. But we should not only call on him - you are all voted into office to talk for everyone here and everyone outside here. You all have a voice and an influence to influence the situation. I'm not here to talk about PARCC - I'm not talking here about education - I'm talking about what I don't agree with – but that is my opinion. I'm here to talk about air conditioning. My kids are in a room without air conditioning. It was 85 degrees outside, can you imagine what is like inside. It is just my opinion – you all have an opinion and you all can help. Talking about no cost – at no cost is PARCC put into place – true, no cost. It is disrupting the classrooms, it's disrupting our children's education - that is not cost? You are all trying your hardest to get this town up and running – that is in the right direction. I see progress. The movie theater is open, there is a vegan shop that is not in Westfield, that is not in Cranford, that is not in Elizabeth - it's here. There is a noodle shop and a sushi shop – this town is coming – but without our schools we are nothing. We need your help.

Mr. Arminio stated please direct your questions to items on the agenda. You will get a chance at the end to make general comments.

UNFINISHED BUSINESS/NEW BUSINESS:

Mr. Arminio stated that tomorrow at 9:00 a.m. at Union High School is the 4th and 5th grade track and field extravaganza. You should come and watch the 4th and 5th graders compete tomorrow at Union High School field. Come and watch and cheer.

We did well in the County tournament in track – we have a number of extraordinary individuals – Justin Stewart, the Union County hurdle champion, the girls track team was 1st

place in the conference – Hayeisha Ursalin(?) who is not only the State top athlete for the NJSIA – she was just awarded that, she is also has a full scholarship to the University of Cincinnati in track – she is the four time champion in 200 meter race. This year she took three 1st places in the 100 meter dash, 200 meter dash and the 400 meter dash. Pretty impressive. Taylor Whiticker placed first in the shot put and is the County champion and 1st place in the discus and is the County champion. Adora Manonee(?) was first place in the high jump and she is the County champion and Necca, her sister, was first place in the high jump and conference champion and 2nd place in the County tournament and conference champion.

The Union High School Varsity softball team has reached the second round of the State tournament and they will be playing on Wednesday, May 20th – right here at Union High School. So some great things looking forward to in the next few days.

Hayeisha Ursalin(?) the student who received a scholarship for the University of Cincinnati for track — but there were other scholar athletes — Lumis Alverado, the Union County Athlete, will be attending Columbia University on an academic scholarship as well as being a terrific athlete and Adora is getting a scholarship to Rutgers to play soccer — which is commendable to all of them — so congratulations to all our athletes.

Livingston and Battle Hill both have their third annual Bubbles for Autism event. Livingston raised \$500 and Battle Hill raised \$700 for autism. Congratulations to the elementary schools.

As Mr. Tatum mentioned, the Rising Star Awards is coming up at Paper Mill Playhouse – June 2nd and I am going to mention that we have 16 nominations – but I didn't think it would be fair for those individuals so pardon me and I am going to read each nominee – Union High School – Jasmine Durham, receiving an award for Assistant Director, Dylan Worst, is a deck chief and student achievement award, Sophisticated Ladies, accompanying hair and make-up, nominated for that, Karen Criss is nominated for costumes, Cosby Chasmen-Beck received a nomination for lighting, Eric Marchetta received a nomination for scenery, Jennifer Williams and James Mosser for choreography, Katie Mosser and Laura Mueller for music direction, James Mosser for director of orchestra received a nomination for orchestration, the Sophisticated Gentlemen received a nomination for featured ensemble, Kristin Adap received a nomination for performance in a featured roll, Javon King received a nomination for supporting roll, James Frazier and Jonathan Duvelson both received nominations for best leading actor in a production and Bernice Onanuga received a nomination for actress in a leading roll and I guess the best for last, the whole show received a nomination for outstanding overall production. That is more nominations that we have ever received – 16 overall.

COMMENTS FROM THE PUBLIC:

Jill Hall, she wanted to extend her congratulations to her former students in the show and 15 of the 18 of the jazz band ensemble are Kawameeh former students – shows a level of excellence in our schools. She stated that March madness concluded and she has pictures from the dancing with the staff event – 62 student dancers, 13 teachers, 20 teacher volunteers and 375 tickets sold. The children bought \$640 of water balloons which were then thrown at the principal and vice principal. \$4,100 was raised for LoveOne46. LoveOne46 foundation

recognized our schools by inviting us to their gala – and they wanted to know what we did to get the school to come together and raise the money because we had 100% participation. She wanted to thank everyone for their support and she said that the next event is a reading competition.

Mr. Armino stated you can go to the Kawameeh website and watch the dancing event.

Mr. Layden stated he wanted to commend Jill Hall, she is an asset to our school district and that we are lucky to have her. Also, he attended his daughter's instrumental concert at Kawameeh and Mr. Brenner, the director over there, it was an amazing concert. He said you can see how with the Union High School program - it starts in the elementary level. It was an amazing concert.

President of the Education Fund – (inaudible) scholarship was given in memory of the science supervisor who passed away and was given to a science student in his memory. If a student had a desire and they came to him – he would let them into honor program as long as they had the motivation – which he had said was just as important as grades – he would give them an opportunity and the Ed Foundation carries on that same philosophy – to a lot of students that was their way out.

Student No. $1-8^{th}$ grade boy from Burnet Middle School – he commented on the boys' locker room. He stated that there are no windows in there (and the girls have windows in their locker room) and there is no ventilation and no circulation in there. He stated that last year the skylight was boarded up and now there is no air at all coming in. He said in the upstairs locker room they have a fan – but it doesn't do any good. He stated after gym class, it is hard to breathe in there and for the kids with asthma – it is very hard for them. He wants to know if anything can be done about this situation.

Mr. Arminio asked Mr. Wiggins on an update on the air conditioning. Mr. Wiggins stated that currently they have all the air conditioners for all the classrooms at Battle Hill – most of the materials and have one crew for the first floor and one crew for the second floor. They are awaiting on some more material – anticipates all air conditioners in every single class room in the next few weeks – if everything goes perfect.

Mr. Nufrio stated with respect to the student and his comments on the lack of circulation/air – to look into it. Mr. Wiggins stated that the skylight was boarded up because it was leaking; however, it did not provide any ventilation. But I will look into it.

Student No. $2-8^{th}$ grade boy from Burnet Middle School – he spoke about paper and that there is not enough paper in their school and field trips they set up are boring.

Student No. $3 - 8^{th}$ grade boy from Burnet Middle School – he stated that he didn't think PARCC benefitted the students because most of the questions on the test they hadn't learned yet.

Parent: (inaudible) complimented the Board and complimented the teachers for all they do and their commitment to the students. The teachers, students and parents need to work

together. We need to find a way to discipline our children – find them things to do instead of suspension. We need to prepare them for each school year – give them a packet of questions to do over the summer.

Student No. $4 - 8^{th}$ grade girl from Burnet Middle School – spoke about dress code and how the rules for dress code are different for the boys and the girls and the girls get in trouble but the boys don't.

Mr. Arminio wanted to thank his special guests for their comments and coming tonight and he hoped they learned something about how a meeting is conducted. Mr. Damato stated Mrs. O'Neill and Mr. Costello's Honors 8th Grade Social Studies class.
