Project Description

There will be three goals for this year's grant. One is to update existing cameras that we have throughout our school district that are over eight to ten years of age and are failing. This will include replacing any parts, replacing the entire camera that is damaged and not working or refocusing cameras that are already installed to show areas that we have learned are more high risk and need video recordings.

The second part of this grant will be to purchase two servers for our district security camera system. One is presently damaged and we are unable to see several cameras at two school locations. We have learned that due to the amount of cameras we have district wide a spare server is also needed at all times in case one goes down.

The final and third part of this grant will enable us to hire a private company to come in and evaluate our emergency security plans. Our plans are presently 8 years old and we are seeing that they need to be update or revised. We want to make sure that all of our plans coordinate with New Jersey and federal regulations. This new plan will enable us to produce a booklet that would be given out to all of our faculty and staff. The company that we would like to contract is from New Jersey and has done this type of work for other school districts in New Jersey. The company will sit with our stake holders and prepare a plan or review our present plan, present it to our stake holders and then present it to our entire faculty and staff at a pre-planned meeting. This new plan will also enable us to update our plans in-house and distribute the updates as needed to each staff/faculty member.

Last year we received a security grant and the monies were earmarked to upgrade our district wide school cameras. Several of the cameras that we replaced were older cameras from a system that was installed over 10 years ago. SWI our camera company replaced those 14 cameras and repaired several other cameras.

This process has now become part of our yearly camera maintenance and replacement program. This year we have been advised that we may be receiving the grant again. We plan to replace at least 10 more cameras.
