Applicant agrees to defend, indemnify and hold harmless the Swim Pool Utility, Township of Cranford, the Township of Cranford's officials, officers, agents, servants, representatives, and employees harmless from and against any claims, liability, damages, costs or expense of every kind and nature arising from or in connection with the Applicant's use of facility, including injuries to persons (including death) or damage to property. The Applicant shall use counsel reasonably acceptable to the Swim Pool Utility & the Township of Cranford in carrying out its obligations under this section. The Applicant shall reimburse the Swim Pool Utility & the Township of Cranford for any and all damages to real or personal property of the Swim Pool Utility & the Township of Cranford caused by the acts of the Applicants or its employees, servants, representatives, agents, licensees, members and guests. The Applicant's duties under this section shall remain fully in effect and binding, without being lessened or compromised in any way, even where the Swim Pool Utility &/or the Township of Cranford is alleged or is found to have contributed to the acts giving rise to the claim, except to the extent the claims shall occur as a result of the willful misconduct, whether by act or omission, or the sole negligence of the Swim Pool Utility &/or the Township of Cranford. The rights provided in this section for the benefit of the Swim Pool Utility &/or the Township of Cranford shall encompass the recovery of attorneys' and other professionals' fees expended in pursuing a claim against a third party.

The Applicant shall carry and maintain insurance as follows:

Commercial General Liability - insurance shall cover for bodily injury and property damage, advertising and personal injury liability with minimum limits of not less than: \$1,000,000 each occurrence for bodily injury and property damage liability combined, \$2,000,000 for the General Aggregate Limit (Other than Products - Completed Operations), \$2,000,000 for Products - Completed Operations Aggregate and a \$1,000,000 limit Personal and Advertising Injury. It is hereby agreed that said policy shall name the Swim Pool Utility & the Township of Cranford as Additional Insured on a Primary & Non-Contributory Basis, and Waiver of Subrogation shall apply.

The applicant has read and does agree to comply with all terms on this contract, in addition to the rules and regulations that are attached, and does agree to pay promptly the charges as stated on the contract. You must be in and out of the facility at the contracted time or you will be subject to an additional fee.

All pools and the immediate areas will remain closed for 30 minutes past the last visible lightning strike or thunder.

Pool rental fee \$550.00 per hour (\$275.00 per 1/2 hour or any part of).

Swimmers will be whistled out of pool 15 minutes before end of rental. Large groups, may begin exiting 30 minutes prior.
