Mr. Nufrio stated at this time I would like the Board members to submit to me via email your requests or preference on committee assignments. This way I will review your requests and move forward with it. I appreciate if I could get it by Friday if possible.

I. UNFINISHED BUSINESS:

J. NEW BUSINESS:

Mr. Arminio stated I would like to remind everyone that Monday is Martin Luther King's Day and there is a gathering at Hannah Caldwell School. I hope everyone comes out to that.

Today and I wish everyone could have been there – Union High School had an assembly this morning and it was a World War II veteran named Bob Max who shared his story to 400 high students. Mr. Max was a college student in Ohio and he and his fraternity brothers decided to enlist in the Army to fight against the Nazis in World War II. He entered the Army and during the Battle of the Bulge which was in 1944, he was captured and sent not to just a POW camp but to a slave labor camp because he was Jewish. He went from, among many other details, 155 pounds when he was captured to 89 pounds when he was liberated by US troops at the end of the war. He came back to the United States and spent 10 months in a hospital recuperating from the way he was treated.

The 400 students, including the entire ROTC, who attended were spell bound by his story. You can go on the internet and he has a website called "*The Long Journey Home*" and find out more details.

The Freeholders, the Township Committee and the Board of Education were represented at the assembly and I think we owe a special thanks to Sgt. Michael Boll who spearheaded this along with Nicole Ahern to get him here to speak to the students. It was an amazing two hours listening to him talk about his experiences in World War II.

By the way the ROTC had done a fundraising and collected over \$3,000 and donated to the Puerto Rican Hurricane Relief Fund and Sgt. Boll will forward it to the group in Puerto Rico.

Mr. Monge stated through Sgt. Boll's not-for-profit organization, a collection of Union residents, shortly after Maria hit Puerto Rico, gathered together and started an initiative called the 21 Project after Roberto Clemente, a historic baseball figure but also a humanitarian who lost his life trying to offer his service to earthquake victims in Latin America. We were trying to raise \$21,000 and we did a great job raising that money for the United Puerto Rico which has raised millions of dollars and putting out funds. I am very thankful to the students and the ROTC for making that possible to reach our goal. That is amazing — God bless you.

Mr. Nufrio stated with regards to Mr. Max – something just came to mind. I would suggest that this Board consider drafting a resolution to honor Mr. Max and make it a formal presentation and if we can get him to come at the regular meeting. If he can't we can still draft a resolution and send it to him. Mr. Arminio will you take charge of that.

Mr. Monge stated we found out a couple of days ago about the ROTC's efforts and if there could be some acknowledgement to the ROTC and their efforts. Mr. Nufrio stated you can do that as well. I would suggest since Mr. Max in all likelihood cannot attend, I will request a copy of the DVD so he can view it at home – seeing how the Board acknowledged his life.

K. COMMENTS FROM THE PUBLIC:

Mrs. Susan Lipstein stated I am speaking here as a private citizen. Ordinarily I don't come up at a reorganization meeting. I clap and say a quick prayer that the Board will do what it is supposed to do and do the best for the District.

This year I am speaking because the campaign from November is now over and a lot of the campaign ugliness that upset the community and I haven't gotten over it yet. But I want to talk about the literature that was sent out that gave total misinformation about the state of our school district and a lot of people believe it and I am concerned that the new Board members may have believed it as well. Concerned citizens contacted the Superintendent and we all received a five page response to the information that was sent out. I can't read all of it – but #2 – violent incidents increased 78% which was in that literature – and according to the truth, the violence did not increase, data for 2015-16 and 2016-17 indicated that it decreased by 2 incidence of violence. In order for everyone to be on the same leveled playing field today, I am going to hand out a copy of this response to all the Board members and a copy to the secretary because I think it should be included in the minutes.

If we really are going to be working together to make a better school district, we all need to be on the same baseline of understanding where this District is and not with whatever was given out in the campaign.

I also want to say that I'm a little upset about changing the dates of the meeting. It has been posted already and I know I always clear my schedule to try to make this meeting and I think a lot of people were surprised tonight about going to two meetings, especially some Board members who said that they cannot come. I just find that a little disconcerting to me that we are now going to have to have votes and a power battle it appears of these meetings. I am not getting a good feeling about that and I think maybe you should go back and schedule that

meeting in one day and catch up everybody because I think it can be done. That is what I would do. You have people that said that they couldn't come. I don't think that is the way to do that. That is my impression of what happened here. I think you all need to cooperate and get together and that is what we need to do and you need to think about that as well.

Document from Mrs. Lipstein appended to minutes.

Mr. Nufrio stated thank you Mrs. Lipstein and I am listening to that comment. I guess with all due respect the only individual who expressed that he was not able to attend is Mr. Monge. Mrs. Lipstein stated I'm just asking for the kind of cooperation and integrity.

Mr. Nufrio stated I would like to ask the Board if there are any other Board members that will not be able to attend the 23rd? Mrs. Regis-Darby and Dr. Francis both stated they could not.

Mr. Nufrio stated Mr. Griggs may I go back to that resolution/vote and ask for a reconsideration of it given the circumstances since I only knew of the one individual.

Mr. Griggs stated you can do a motion for reconsideration.

Moved by Mr. Nufrio, seconded by Mrs. Minneci, for reconsideration of the meetings.

DISCUSSION:

Mr. Monge stated other folks that had plans to come to the regular meeting – those plans could now be an issue. Mrs. Lipstein stated you need to work with the community.

Mr. Nufrio stated the only concern I had was whether or not Mr. Tatum and the rest of Central Office was prepared to move forward with the resolutions. Mr. Tatum stated we haven't had our agenda review yet, it is scheduled for tomorrow afternoon at 2 p.m. and I'm not in this week, I'm doing this on my vacation time. Mr. Nufrio stated if we can do it in the morning or later in the afternoon that would be fine. Mr. Griggs stated you have 2 p.m. with me. Mr. Tatum stated 12 noon then. Mr. Nufrio stated that is fine.

Mr. Tatum stated as far as the 23rd is concerned it is reserved for a meeting but at this stage of the game, I don't know if any of the Assistant Superintendents are available that night and I certainly know I am not but if need be I can readjust my schedule but at this point I'm not available on that evening.

Mr. Nufrio stated I don't have a problem with that and that is why we have another resolution to consider but I wish you would have spoken up.

Mr. Monge stated what about January 30th. Mr. Nufrio stated I don't think it is wise to use that date again based on January and unforeseen stormy weather. Right now the motion is to schedule both meetings for next Tuesday. Unless we are going to do the committee meetings, then we would start at regular committee times. The condition that we are going to reschedule next week is that it is a combined worksession/regular meeting and then we go by the schedule

of the worksession committee meetings which usually start at 5:30. We will still have to do it here since it is a regular meeting as well. I guess we can have committees here.

Mr. Tatum stated I will work with the high school administration to find rooms to have committee meetings. Mr. Nufrio stated we can do that tomorrow after we conclude the agenda review and we will have a better understanding and then we can inform the rest of the Board where the committee meetings will be. Since we are going to be doing that, I stress that you send me your preferences for committee assignments by Thursday.

Mr. Tatum stated residency meetings – she rescheduled those meetings for next week because they were supposed to be tonight. I think you can have them at the Administration Building but I guess it is how it crosses over with other committees. How it worked out last year there wasn't any crossover between the committees. If there are no crossover I think we will be o.k.

Mr. Nufrio stated that is why there is an urgency for you to get preference list to me for committee assignments. I will be sure to have that returned to you by Friday.

Mr. Griggs stated right now you have on the floor a motion for reconsideration so you need to take action on that and then you need a motion to schedule the meeting you described.
