

WHEREAS The Township and the Board entered into a School Resource Officer	
Agreement in 2016 for the Township to pro	ovide the Board with a School Resource Officer
("SRO"); and	
WHEREAS, the Township and the	Board wish Amend the 2016 School Resource
Officer Agreement to continue the terms of the School Resource Officer Agreement for the	
2017-2018 school year.

agreed that:	
1. The Township shall provide to the l	Board a SRO for the 2017-2018.
2. The Board agrees to pay the Township for the SRO's services, \$40,000 with payment to	
be made no later than July 2018, upon the submission by the Township of a fully	
executed Board Voucher.	
3. All other terms set forth in the 2016 School Resource Officer Agreement shall remain in	
full force and effect.

WHEREAS, the Governing Body of the Township of Union (the "Township) and the Board of Education (the "Board") entered into a contract for the joint provisions of services pursuant to N.J.S.A. 40A:48-5 and N.J.S.A. 40:4A-1 et. seq. for the services of a school resource officer for the school years September 2010 - June 2017; and
