Business of the Board:

NJSBA- Board's Role in Budget & Finance & Review of Financial Statements:

Ms. Jeanne Cleary, the district's Field Service Representative spoke in detail to the board on sharing basic fundamentals by understanding definitions commonly used, spoke about NJQSAC, which our district is currently going through. Provided Board's role in Overall financial responsibilities, planning & policy development, Budget and audit. She explained in

TUPS Budget Proposals

Update on Instructions & Program; QSAC

He was able to breakdown the NJ Student Learning Assessments data in various categories i.e. male, female, ethnicity, special education, 504's, grade, subject, etc. He compared the date to county and state. Board members were very engaged in the information presented. They asked a myriad of questions and different perspectives on numerous tests the students are taking.
