Mr. Arminio called the meeting to order at 7:05 p.m.

Mr. Salcedo led the board and audience members in the Pledge of Allegiance.

Mr. Damato read the statement required under the "Open Public Meetings Act", a copy of which is on file in the office of the Board Secretary.

## **BUDGET PRESENTATION:**

Mr. Arminio stated to Mr. Vieira that he has the floor.

Mr. Vieria stated good evening everyone – I would like to present our budget for fiscal year 2015-2016. I am pleased to present our budget for Fiscal Year 15-16. There is good news to share with you as we prepare for the 2015-2016 school year. Although our school district did not receive any additional state aid, we maintained all programs. A 2.1% local tax rate increase and healthy fund balances allow us to move forward with a balanced budget. Two of our largest challenges are controlling the cost increases in employee health benefits and Special Services. Our 2015-2016 Total Budgetary Comparative per Pupil Cost is \$14,465. We have approximately 1200 employees and 7500 students.

Our total budget is \$130.5 million that consists of:

General Fund: \$124.8 mill
Special Rev Fd (fed, state grants, NCLB, IDEA): 2.8 mill
Debt Service Fund: 2.9 mill

For a total of \$130.5 million.

We received \$31.9 in State aid which is approximately 1/4 of our budget and our total local tax levy is \$87.1 million which is 2/3 of our budget

Appropriations/expenditures - More than \$63 million dollars is appropriated for instruction. Next is the employee benefits \$23.8 million dollars. I will go back to the General and School Administration/Central Services/Tech which is \$8.7 million. Our debt service is \$2.9 million. Operation and maintenance is \$10.5 million. Student Support Services is \$13.5 million and transportation is \$5.8 million. For a total of \$130.5 million.

What probably most people are interested in is the tax impact on the average homeowner in Union. General Fund tax increase is \$85.86. There is a decrease in our debt service because we refinanced \$5 million in bonds which lowered our debt service (-\$2.76) which is passed on to the tax papers. So the average increase to the homeowners in Union is \$83.10. Tomorrow I will post a user friendly budget on our district website – there will be more details there.

Next is the presentation that has to do with some of the highlights of our programs. Like I said a lot of our programs will be maintained – pre-k kindergarten, full-day kindergarten, all the academic programs pre-k through grade 12. Also maintaining our comprehensive program of athletics and co-curricular activities throughout the school district.

#### Some of educational advances:

- Guidance integration of technology into elementary and middle school classroom lessons;
- Performing Arts/Music increase size of the high school marching band for the 2015-2016 school year and competitive season;
- Social Studies implementation of writing initiative based on the PARCC writing format using the NJCCS writing rubic;
- Science implementation of the next generation science standards and high school STEM new course digital electronics
- Phys Ed CPR for all district 11<sup>th</sup> graders
- Career Education CAD IV 3D modeling and rendering
- Elementary level pre-k rediness and writing kits, I Ready which masters reading and mathematics program, science fusion for grade 2 and go math upgrade

For the next school year the physical plant highlights include bathrooms districtwide, sidewalks districtwide and new classrooms at the Burnet Middle School.

In concluding our Board of Education, staff and students, thank you, the residential and commercial taxpayers of Union for your continued financial support of the Union Public Schools.

## FISCAL AND PLANNING COMMITTEE RESOLUTIONS:

- F-1. The committee recommends and I so move that there should be raised for General Funds \$84,295,227 for the 2015-2016 school year (includes \$1,000,000 for increased health benefits).
- F-2 The committee recommends and I so move that the board include in its proposed 2015-2016 budget an additional amount of \$1,000,000 for increases in health benefits in accordance with the information in the hands of each board member.
- F-3. The committee recommends and I so move that the board approve withdrawal from Capital Reserve to Capital Outlay (Fund 12) in the amount of \$1,155,000 for the following projects (a) Asbestos Removal Districtwide \$55,000; (b) Bathrooms-Burnet Middle School \$33,000; (c) Bathrooms Union High School \$165,000; (d) Bathrooms Washington School \$33,000; (e) New Classrooms Burnet Middle School \$825,000; (f) Sidewalks Districtwide \$44,000 in accordance with the information in the hands of each board member.
- F-4. The committee recommends and I so move that the board approve withdrawal from Maintenance Reserve in the amount of \$600,000 for required maintenance in accordance with the information in the hands of each board member.
- F-5. The committee recommends and I so move that the board approve Travel Expenditure Maximum in the amount of \$80,000 in accordance with the information in the hands of each board member.
- F-6. The committee recommends and I so move that the board establish a maximum dollar limit for professional services and public relations in the amount of \$875,000 in accordance with the information in the hands of each board member.
- F-7. The committee recommends and I so move that the board authorize the Superintendent and the Business Administrator to implement the 2015-2016 school budget and tax levy pursuant to local and state policies.
