Dear Mrs. Koon;

At your request the HCESC Lease Purchase Advisory Service conducted a RFQ (Request for Quote) for the Board of Education of the Township of Union (Board) for lease purchase financing. The following is the summary of the results, analysis and recommendation for award.

The Quote was opened, September 21, 2023, at 1:00 p.m., at the offices of the Board's Business Administrator. The Board solicited Quotes for lease purchase financing to pay for the acquisition of three 24 passenger school buses and any costs of issuance.

The aggregate principal amount for this lease purchase is approximately \$277,912.95. The term requested was four years with four equal annual payments in advance. Funding to escrow is anticipated on October 15, 2023. The four equal annual payments are commencing May 1, 2024. The escrow account should be closed with the payment release for acceptance of your last associated invoice.

The respondents were requested to furnish an interest rate for closings within 30 days. Due to uncertainties in the banking community, the financial community have gone to internal pricing models so our normal request for an indexed rate has been suspended. The respondents were asked to furnish what their penalty for early payoff would be for the aforementioned.

Respondents were asked to disclose any additional charges for escrow accounts or documentation fees if applicable. For purposes of the RFQ document, closing for the lease purchase was set for October 15, 2023. Respondents were requested to furnish a payment stream as a function of their interest rate given the requested parameters.

HCESC uploaded RFQ specifications and links to financial information of the Board to the HCESC web site for access by potential respondents. Fifty eight potential respondents were identified. An e-mail with links to the RFQ and financial information was sent to the potential respondents. There were five respondents submitting a responsible Quote.
